

**[SUMMER 2020] COMMUNICABLE DISEASE
RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT**

I, _____, hereby acknowledge, appreciate, and agree that my son or daughter is being permitted to voluntarily participate in Soccer Training and/or Scrimmages with various coaches normally associated with the Pal Mac Soccer Club summer teams. However, due to the COVID-19 pandemic having resulted in the cancellation of our 2020 summer league, all such participation (a) is not officially affiliated with Pal-Mac Soccer Club, (b) is not insured under NYSWYSA secondary insurance plans, and (c) carries with it the risk of exposure, directly or indirectly, to any and all communicable illnesses, including but not limited to, "severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2)", which is responsible for Coronavirus Disease (COVID-19) and/or any mutation or variation thereof.

I acknowledge it is my sole responsibility to ensure that neither my child(ren) nor I shall play, practice, participate or attend any of the soccer training activities unless:

- (1) our temperatures are below 100.4 degrees;
- (2) we are not experiencing COVID-19 like symptoms; and
- (3) neither we nor anyone in our household has knowingly been in contact with anyone who was exposed to or has tested positive for COVID-19 within the preceding 14 days.

If, however, I observe any symptoms of COVID-19 during my child(ren)'s or my participation or presence at a soccer training or scrimmage event, I will immediately advise the supervisor, coach, or official and remove my child(ren), myself, and any additional members of my household, from the premises where the event or activity is being held.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any communicable illnesses and any complications, disabilities, permanent injuries, or death associated therewith, contracted by my children, myself, and/or any other members of my household, together with any liability, claims, actions, damages, costs, or expenses, of any kind, incurred in connection thereto.

I hereby forever release, covenant not to sue, discharge, defend, indemnify and hold harmless the Pal Mac Soccer Club, the Town of Macedon (or any other facility owner where these activities may occur), its affiliates, employees, representatives, successors, agents, assigns, heirs, partners, or any other person or entity vicariously liable for them, of and from any and all liability, claims, actions, damages, costs or expenses of any kind arising out of or relating the contraction of a communicable illness, by my child(ren), myself, or other members of my household, during or following my child(ren)'s or my participation in the activity.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
